Credit Terms And Credit Agreement

The undersigned agrees to pay for all fuel, lubricants and other products within 15 days after invoice date. The undersigned further agrees to pay a finance charge of 1 ½ % per month (18% annual rate) on all past due amounts; a handling charge of \$25 for each returned check, and all collection and legal fees whether or not court ordered. In the event of a lawsuit or other legal proceedings, customer covenants and agrees that Monterey County, California shall be the only proper venue. To secure payment of all amounts due Sturdy Oil Co., customer hereby grants to Sturdy Oil a security interest in the inventory and the proceeds of inventory. Customer agrees to receive invoices and statements from Sturdy Oil in electronic format via email to the address provided on the front of this application. Sturdy Oil shall have all remedies as provided in the uniform Commercial Code upon default including the right to take immediate possession of customer's inventory. The undersigned hereby states that he is authorized to bind the customers to the terms hereof.

For purposes of establishing and continued credit with Sturdy Oil Company I hereby authorize any credit investigation needed for verification at any time.

INDIVIDUAL PERSONAL GUARANTY

(Hereinafter "Guaranty")

I, _____ (*hereinafter referred to as "Guarantor"*) residing at _____ for and in consideration of your extending credit at my request to _____ (*hereinafter referred to as "Company"*), of which I am _____ (*title*), (*and the owner of a direct or indirect interest in Company such that this guaranty may reasonably be expected to benefit me directly or indirectly*), hereby personally guaranty to Sturdy Oil Company ("*Sturdy*") at Salinas, California, of any and all obligations of the Company of every kind and character, irrespective of the amount of said obligations, whether now existing or hereafter arising, including interest on any of the obligations and any and all costs, attorney's fees, and expenses suffered by Sturdy or Sturdy's assigns by reason of Company's or Guarantor's default in payment of any of the foregoing indebtedness, and any renewal, extension or rearrangement to the indebtedness, costs, or expenses associated with such default. Guarantor hereby agrees to pay Sturdy promptly on demand any sum which may become due to Sturdy by the Company whenever the Company shall fail to pay the same. It is understood that this guaranty shall be a continuing, unconditional and irrevocable guaranty and indemnity for such indebtedness of the Company. Guarantor hereby agrees with Sturdy that all rights, remedies and recourses afforded to Sturdy by reason of this Guaranty or otherwise are separate and cumulative and may be pursued separately, successively or concurrently, as occasion therefore shall arise, and are nonexclusive and shall in no way limit or prejudice any other legal or equitable right, remedy or recourse which Sturdy may have. Guarantor hereby waives notice of default, nonpayment, and notice thereof, and consents to any modification or renewal of the credit agreement hereby guaranteed. This Guaranty is binding on Guarantor and Guarantor's heirs, personal representatives, successors and assigns. If any provision of this Guaranty or the application thereof to any person or circumstance shall, for any reason and to any extent, be invalid or unenforceable, neither the remainder of this Guaranty nor the application of such provision to any other person or circumstances shall be affected thereby, but rather the same shall be enforced to the greatest extent permitted by law.
